

Terms and Conditions

- *The promoter is Adelaide Economic Development Agency (“**AEDA**”) (ABN 76 182 348 392), a subsidiary of the Corporation of the City of Adelaide (“**Council**”), and the organiser of ADL Fashion Week.*
- *These are the Terms and Conditions for the **ACLER runway show double pass at ADL Fashion Week (“Competition”)**.*
- *Participation in the Competition is deemed acceptance of these Terms and Conditions. Terms and Conditions are subject to change without notice.*
- *The Competition opens on Wednesday 10 September 2025 at 10:30 am ACST and closes on Sunday 21 September 2025 at 11:59 pm ACST (“**Promotional Period**”). Entry to the Competition is free.*
- *To be eligible for the Competition, participants must complete the following steps within the Promotional Period:*
 - *Subscribe to the ADL Fashion Week e-newsletter by providing the requested details; and*
 - *Submit the fully completed online form.*
