

**TERMS & CONDITIONS**

### **How to Enter**

To enter the customers simply:

1. Make a purchase of \$150.00 or more (to receive one entry) at any businesses located within the Rundle Mall Precinct (see map below) on Friday 11 October 2024 to Sunday 13 October 2024.
2. Visit the Shop & Win activation, located at the Gawler Place Intersection and provide your name, email and purchase details to the Shop & Win staff and agree to subscribe to the Rundle Mall, What's On and ADL Fashion Week mailing list to go into the draw.
3. Show your physical receipts for proof of purchase to the Shop & Win staff to have your receipts verified and stamped.
4. Customers will be able to enter more than once into the competition, provided they spend an additional total of \$150.00 in a single day and follow the steps above each time.
5. Eligible purchases must occur on the same day as the competition is entered.
6. Persons under the age of 18 years old are permitted to enter the promotion provided parental/guardian consent is obtained.
7. All valid entries will be automatically entered into our major prize draw.

### **Duration of competition**

The competition opens at 9:00am ACST, Friday 11 October 2024 and closes 4:59pm ACST, Sunday 13 October 2024.

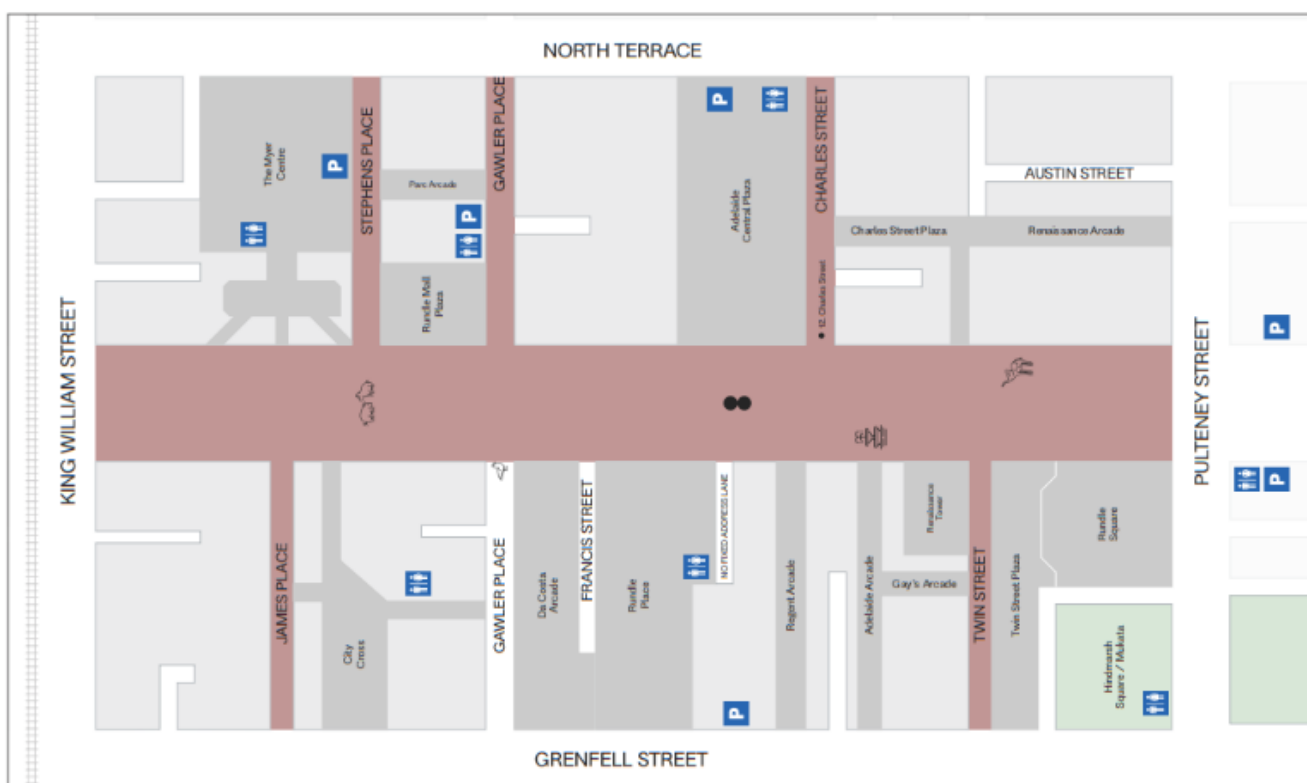
### **Conditions of Entry**

1. Information on 'how to enter' forms part of these 'Conditions of Entry'.
2. Customers may receive one entry per \$150.00 spent within the Rundle Mall Precinct on the corresponding day of competition entry.
3. Each entry requires proof of purchase in the form of a receipt from a business within the Rundle Mall Precinct. The purchase must have been made during the promotion period and date shown on receipt must match the corresponding competition entry date.
4. Each eligible entry must have receipt(s) totalling minimum spend of \$150.00 accumulated within one (1) day.
5. Customers may enter more than once, but each entry requires proof of purchase(s) in the form of receipt(s) from a store(s) within the Rundle Mall Precinct. The purchase(s) must have been made in the same day as the competition is entered.
6. Receipt must be fully legible and be from a business within the Rundle Mall Precinct.
7. Entries received after the close date will not be considered.
8. Entries will not be accepted via post, they must be made in-person at the Shop & Win activation.
9. Entries illegible, forged, mutilated, copied, or tampered with in any way will not be considered.
10. Employees of the City of Adelaide are ineligible to enter.
11. Management and staff of businesses in Rundle Mall are permitted to enter as long as they do not present receipts from their place of employment.

12. Receipts from partial lay-bys, bill payments such as the payment of credit card bills, bank transactions, bank fees and charges and service bills [such as gas, electricity, rates and phone bills] cannot be presented as receipts to enter.
13. Receipts from lotteries, tobacco or liquor cannot be presented as receipts to enter.
14. The person collecting the prize must provide suitable identification to the promoters' satisfaction to be entitled to claim the prize.
